Additionally, we made a major contribution to the Vision Benefits of America Opportunity Scholarship at PCO which helps doctors in training complete their path to becoming new eyecare providers in Pennsylvania.

I would like to recognize the Central Pennsylvania Optometric Society member Doctors for their very generous donation to our Foundation. This positively impacted lives in Central PA by providing vision care for many individuals in Adams, Cumberland, Dauphin, Franklin, Juniata, Lebanon, Perry, Snyder and York counties.

### **The Vision Benefit Program**

The benefit program ensures that adults and children who qualify for this need-based program have access to receive quality eye care through local VBA providers.

#### What's Included?

Participants in the Vision Benefit Program receive an exam, eyeglass frames and lenses from one of VBA's Participating Providers.

### Who Qualifies for Our Benefit Program?

Adults and children residing in Pennsylvania who are underprivileged, distressed and live at 300 percent of poverty level or below.

### **The Latino Community Center**

The Latino Community Center (LCC) is a Pittsburgh based non-profit organization founded in 2017 providing families with immediate needs as well as the tools to build a bright future.

With a focus on the future, LCC has programs to support families with children from birth through college. Their programs give community members the tools and opportunities needed to reach their full potential through educational programming, family support and community building.

LCC envisions a world in which all people are valued and have equitable opportunities to thrive. From home visiting programs focused on the well being of new parents and babies, to parenting classes that focus on discipline, parents gain skills to help their children flourish. LCC continues to work with parents and children through after school programs, high school and career support.

To meet immediate needs, LCC provides community members with necessities like food and dental care. To aid in it's mission, The Pennsylvania Vision Foundation provides vision exams and eyeglasses to members of the LCC community who need them.

In 2025, LCC will establish a Latino Youth Center to extend it's mission. It will provide a safe, welcoming space where youth feel valued.



### The Perfect Pairing: Exams and Screenings

Vision screenings and vision care exams are complimentary methods of identifying potential eye issues. According to the CDC, approximately 1 in 4 preschool-aged children have undiagnosed or untreated vision problems. Since children often don't know their vision is blurry, vision screenings play an important role in identifying potential issues at an early age.

### **Vision Screenings**

Vision screenings are a tool to identify children who need additional vision care.


Vision care exams are performed by an optometrist or ophthalmologist to diagnose vision or eye health issues.



### **Partnering For A Better Future**

Our partner organizations performed over 55,000 vision screenings in PA in 2024. They were able to refer almost 6,000 children for vision care exams using the Vision Benefit Program to pay for eyeglasses for qualifying families.

Bucks County Association for the Blind, Looking Out For Kids, Sights For Hope, VisAbility, VisionCorps, VRCBerks and VROCP all perform vision screenings during the year.



### Paving the Way For Eye Doctors

In the next decade, it's estimated there will be a 15% shortage\* of ophthalmologists nationwide. With a shortage in ophthalmologists, it's possible that not everyone will have access to the eye care they need. Optometrists, as primary eye care providers, will need to rise and fill this shortfall.

The Pennsylvania Vision Foundation recognizes the importance of supporting the future of optometry and ophthalmology through investing in students.

We believe a quality education is the foundation of a well-rounded eye care practitioner. Providing an annual scholarship to a Salus at Drexel University optometric student is an important part of serving our mission.

Pennsylvania College of Optometry awards approximately 150 degrees each year as one of 25 optometry schools in the United States. The Pennsylvania Vision Foundation offers this endowed scholarship to ensure a bright future for optometrists in Pennsylvania.

### Access To Eye Care Is On a Roll

In 2024, Salus University at
Drexel hosted a ribbon-cutting
ceremony for the new Mobile Unit
for Health Resources (MUHR).
Formerly the Big Red Bus, the
new mobile facility offers clinical
services through The Eye Institute.
Pennsylvania Ear Institute and the
Speech-Language Institute.

The new mobile unit will continue the mission of providing comprehensive eye care to underserved members of the Philadelphia regional community.

The Pennsylvania Vision
Foundation and VBA are proud to
support the community through
the MUHR. The \$50,000 grant
provided necessary optometric
equipment including: pupilometer,
phoropters, digital visual acuity
systems, iCare tonometer, exam
chairs, handheld autorefractor,
handheld slit lamps, binocular
indirect ophthalmoscopes and
trial lens kits.

### Spreading Kindness with Trucks for Maddox

In 2024, a \$15,000 grant was awarded to Children's Hospital of Pittsburgh Foundation at UPMC for exclusive use in the Trucks for Maddox Optical Assistance Fund. Since 2020, the Trucks for Maddox Optical Assistance Fund has worked to ensure that all children have access to the eyeglasses they need. Through this initiative, Maddox Derkosh's family is able to spread his legacy of kindness and friendship. With the Foundation's grant, 96 pairs of glasses were granted to children in financial need.

### **Meet Trenton**

As a baby, Trenton's mom took him to a local hospital for his care. After he developed RSV, rhinovirus and a collapsed lung, she started taking him to UPMC Children's for his medical care.

The Eye Center at UPMC Children's treated Trenton for strabismus, misalignment of the eyes. In order to avoid surgery, he needed to wear eyeglasses consistently to gradually correct the condition. However, his glasses were thick and heavy which was a challenge, especially as a child with Autism Spectrum Disorder.

Trenton developed a love for the athletic apparel brand Nike. "The eye care team and I thought Nike-brand glasses might motivate him to wear them," Kassidy shares. "It sounded perfect, but I told them there was no way I could afford name-brand glasses, and our insurance will not cover them.

The team at The Eye Center was able to provide Trenton a pair of Nike eyeglasses using a special fund through the Pennsylvania Vision Foundation to help cover the cost of the glasses.

Through Trucks for Maddox, Trenton was able to receive glasses he was motivated to wear.
